On February 10th I was appointed as the 36th Postmaster of Atlanta during an installation ceremony held at Atlanta City Hall. The 2012 GAPCC started the year with several well attended workshops that covered an array of topics from Network

Optimization, Options for Shipping Packages with the USPS, Scan Visibility, Volume Price Break, and Taking Advantage of Great Prices and Services in the fastest growing segment of the USPS. Atlanta District Manager/Lead Executive Salvatore Vacca hosted the Annual Pre-National Postal Forum Luncheon on March 20th adding to this truly great year for the GAPCC. As you know, the U.S. Postal Service suffered several setbacks finishing Fiscal Year 2012
